<b>General:</b>	In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.

## SECTION 6 ACCIDENTAL RELEASE MEASURES

<b>Personal Precautions, Protective Equipment and Emergency Procedures:</b>	Remove sources of ignitions, do not turn lights, or unprotected electrical equipment, on or off.
